To whom it may concern,

From the 24 April, 2025, a change to the formal qualification title of certificates issued to Aptis ESOL International examination candidates will be introduced, in line with current Office of Qualifications and Examinations Regulation (Ofqual) regulatory requirements.

The change that will be introduced is a change to the full Ofqual qualification title that appears under the certificate title Aptis ESOL International Certificate. The changes to be introduced for each level are indicated in Table 1.

The Ofqual full qualification titles to be introduced from the 24 April, 2025, and their corresponding overall CEFR levels, UK Qualification Levels and Qualification Numbers, along with the variant certificate samples attached with this letter are indicated in Table 2.

Aptis ESOL International Certificates issued up to and including the 23 April, 2025 and Aptis ESOL International Certificates issued from the 24 April, 2025 remain equally valid for the purposes of confirming the English Language level of the test taker to whom the certificate has been issued.
