# Recommendation

# New summary statement.

The British Council inspected and accredited Berlitz, Manchester in August 2024 and February 2025. The Accreditation Scheme assesses the standards of management, resources and premises, teaching, welfare, and safeguarding under 18s and accredits organisations which meet the overall standard in each area inspected (see <a href="http://www.britishcouncil.org/education/accreditation">www.britishcouncil.org/education/accreditation</a> for details).

This private language school offers courses in general and professional English for adults (18+) and young people (16+) and for closed groups of under 18s and vacation courses for under 18s.

## The inspection report stated that the organisation met the standards of the Scheme.

# Updated summary inspection findings

#### Management

Overall, the provision meets the section standard. The provision operates in accordance with the providers' stated goals and values. Job descriptions did not reflect additional duties and responsibilities of some staff members and staff absence and changes of staff compromised some aspects of provision during the summer. Publicity is satisfactory.

#### **Premises and resources**

The provision meets the section standard. The premises generally provide a suitable environment for teaching and learning although there is a lack of appropriate relaxation space for students and staff at Westminster House. A range of learning resources is available, appropriate to the age and needs of the students. Guidance on the use of these resources is provided where needed.

#### **Teaching and learning**

Overall, the provision meets the section standard. The academic staff team has a professional profile appropriate to the context and the recruitment and support policy is devised and implemented in line with the stated course objectives and the student profile. Course design and review is satisfactory; however, learning outcomes are not shared systematically with students. The teaching observed met the requirements of the Scheme.

#### Welfare and student services

The provision meets the section standard. The needs of students for security, pastoral care and accommodation are met. However, some information about access to NHS services is out of date. The leisure programme is responsive to student need and is delivered safely.

# Safeguarding under 18s

The provision meets the section standard. The safeguarding policy and related training is good, and measures in the plan ensure the safety of students under the age of 18. References and DBS checks are on file for all staff.

# Declaration of legal and regulatory compliance

# Introduction

# Background

Berlitz Manchester is a privately owned language school and is a franchise of the wider Berlitz organisation, which has schools in various locations around the world. The school offers general and business English courses to adults aged over 16, and a summer vacation course for younger learners on the main site and on seasonal premises at the University of Salford.

This was a signalled spot check to end a period under review due to weaknesses in Safeguarding and Publicity.

# Preparation

The spot check was carried out by two inspectors, both of whom had been involved in the previous inspection in 2024. The inspector contacted the provider in advance to check if there were any dates which would not be suitable and when key staff would be present. The Accreditation Unit sent the inspector relevant documents. Both inspectors looked at this documentation and the Berlitz website.

# Programme and persons present

The inspectors arrived at 09.15 and left at 13.15. They visited the main school site in Westminster House. Face-toface meetings were held with the director of studies (DoS) and the operations manager, and a remote meeting was held with the managing director/proprietor. One class was briefly observed. Focus group meetings were held with students and teachers. Upon arrival, the reporting inspector requested several documents, all of which were provided.

# Findings

# Findings are reported in the following section and in the Action taken on points to be addressed.

# Management

The points to be addressed in the area of *Publicity* were responded to by the provider in communications with the Accreditation Unit in early 2025. These were mostly addressed, although there were still outdated accreditation marques on display in classrooms and on some documentation. There is no information available prior to enrolment on the website or in brochures indicating the level of care offered to students under the age of 18. There is no longer a need for improvement in *Publicity*.

# Welfare and student services

The points to be addressed in the area of *Leisure opportunities* were responded to in communications with the Accreditation Unit in early 2025, and their application was checked during the spot check.

#### Safeguarding under 18s

Staff records show that suitability checks are complete for all adults in contact with under 18s. This was confirmed by the staff files sampled during the inspection. There are consistently applied systems in place for following up late arrival of students aged under 18, and there is clear guidance in place for what students aged under 18 can safely do when not participating in school organised activities. Contact information for individual students aged under 18 was readily accessible. There is no longer a need for improvement in *Safeguarding under 18s*.

Publicity consists of the website and several brochures.

M22 Although the website is generally written in language understandable at the B1 level, some small sections are written in a higher level of English, and there were a few errors in language usage.

M25 There is no information on the website or in the school brochures outlining the level of care and support given to students under the age of 18.

M28 There are signs throughout the school which use an out-of-date accreditation marque. This was remedied during the inspection and is no longer a point to be addressed.

#### Comments

The school enrols mostly adult students through the year, with a smaller number of 16- and 17-year-olds joining the adult general English programme. In the summer months, the school offers a separate junior programme for students aged 12 to 17, delivered at separate premises at a local university, and also some junior provision on the main school premises. At the time of the inspection two of the 69 students registered were aged under 18.

S1 The safeguarding policy is comprehensive and is reviewed annually by the safeguarding team. The policy is supported by relevant documents including codes of conduct and incident-reporting documentation. S2 The policy is shared effectively with staff and other stakeholders through handbooks, induction, briefings and training. All staff and any homestay hosts accommodating students under the age of 18 are appropriately trained. Four current members of staff are trained to specialist level, and a further member of staff to advanced level.

# Action taken on points to be addressed

Points from the previous full inspection and/or subsequent spot checks or interim visits with comments (in bold) to indicate how far these have been addressed. Only points reviewed during this spot check are included here. Any points outstanding will be checked at the next full inspection.

# Management

M10 A number of references were missing from staff files and the recruitment policy currently only refers to teaching staff.

Partially addressed; a full record of references was seen and the sampled entries all had appropriate references. However, the recruitment policy still only refers to teaching staff.

M17 Some of the records sampled did not have up-to-date local contact details and not all indicated the relationship of the emergency contact to the student.

# Addressed: the records sampled had up-to-date contact details and indicated the relationship of the contact to the student.

M18 Although the school has a policy on attendance made known to students, the policy was not being implemented and students seemed unsure of it.

Addressed: inspectors saw the attendance policy being implemented, and staff and students were both aware of attendance procedures.

M21 There was no mention of the junior courses run year-round on the website.

Addressed: the new website includes information about junior courses.

M23 Both the website and the brochures stated a confusing range of minimum enrolment ages. The maximum class size is stated as 15 but classes observed had more than 15 students in some cases.

Addressed: minimum enrolment ages are now consistent, and the maximum class size has been changed to 16 and is consistent across all media of publicity. This was checked with the proprietor as part of this inspection.

M27 The junior course brochure states "all of our teachers are native, accredited", and elsewhere "Berlitz teachers are highly qualified". These claims are inaccurate.

Addressed: this wording has now been removed from the junior course brochure.

M28 The website still states that Berlitz Manchester is "accredited by English UK", a point raised in the 2019 inspection. An incorrect Accreditation Scheme marque was used throughout the school. Addressed: the new website claims accreditation appropriately. However, an incorrect accreditation marque is still used throughout the school. This was remedied during the inspection and is no longer a point to be addressed

# Welfare and student services

W22 Risk assessments for leisure activities do not include measures for responding to critical incidents. The emergency plan is also not shared with the main external provider of full-day excursions.

Addressed: critical incident information has been added to activity risk assessments, and details of the emergency plan have been shared with the external provider of full-day excursions.

# Safeguarding under 18s

S4 At the time of the inspection, two references were not on file for some teaching staff working with students aged under 18.

Addressed. Staff records show that suitability checks are complete for all adults in contact with under 18s. This was confirmed by the staff files sampled during the inspection.

S5 Absence and lateness of students under the age of 18 is not consistently followed up.

Addressed; there are clear systems in place, both staff and students were aware of them, and they were witnessed being carried out during the inspection.

S6 Clear guidance about what students aged under 18 can safely do outside the scheduled programme is not in place. Students aged under 18 studying on the adult programme do not receive separate guidance on safety and the law appropriate to their age.

Addressed: clear guidance is now in place as part of student induction for students under the age of 18, and students sign to show they have understood. There are new procedures for safely managing individual under 18 student visits to other cities.

S8 Contact information for individual students on the junior and adult programmes is not consistently recorded and is not generally readily available to the emergency phone holder.

Addressed: computer-based records of this information are now kept centrally, and emergency phone holders can log in to access this information out of hours if required.

# Conclusions

Publicity is satisfactory. The provider has improved the procedures that it has in place for safeguarding and leisure activities, and the students benefit from a safe and secure environment. Implementation of these improvements and the response to points to be addressed specific to summer provision will need to be verified when summer courses are running.
