EHEA Experts biographies

Michael Blakemore is Emeritus Professor of Geography at the University of Durham and a Technical Director with Ecorys UK. He was involved in building the quality assurance framework for Erasmus Mundus, was part of the team looking at recognition and sustainability for Erasmus Mundus programmes, and more recently in the Erasmus Mundus Quality Review.

Working with them in delivering the Workshops will be other EHEA Experts, providing inputs from the student perspective, from the perspective of using Bologna Tools, in Quality Assurance, and in developing international programmes. The team of EHEA Experts supporting the seminars will include:

Dugald Craig is Acting Chief Executive West of Scotland Colleges' Partnership. Dugald Dugald has worked in European and transnational programmes and projects for 25 years. He is currently Acting Chief Executive with the West of Scotland Colleges' Partnership (WoSCoP). His professional role is to support and advise WoSCoP's member colleges of further and higher education on relevant European policies, priorities and programmes. In an extension to this role, he represents the interests of the Scottish college sector on a range of national advisory, consultative and policy groups - for example, the national advisory group for the EU's Erasmus+ Programme, the UK Sector Consultative Group for Vocational Education and Training and the Scottish Bologna Stakeholders' (Process) Group. As a consequence of his European experience, Dugald has provided expert advice to the European and External Affairs Committee of the Scottish Parliament and Ministers in the Scottish Government on improving Scottish engagement with European programmes. He is a member of the Programme Monitoring Committee for the Interreg IVA Programme for Northern Ireland, the Border Region of Ireland and Western Scotland, the UK's team of Bologna/EHEA Experts, the Steering Committee for the UK's team of ECVET Experts and the General Council of EURASHE (the European Association of Institutions in Higher Education). The evolution of his career, prior to joining WoSCoP, includes four years working in Brussels as Head of Technical Assistance for the Socrates II programme, and some 20 years in the operational and strategic management of publicly and privately funded services in lifelong learning, vocational training, economic development, prison education, language learning and further and international education in various parts of the UK.

Andy Gibbs is Senior Lecturer (International) at Glasgow Caledonian University with experience of design and delivery of Erasmus + KA2 CBHE programmes in addition to experience in supporting the implementation of European Higher education Reforms.







Dr Stephen Jackson is 'Associate Director – International' within QAA, and was previously in the role of Director of Quality Assurance, with overall responsibility for the management and delivery of review activity. This included universities and other higher education providers, the review of higher education in further education colleges and the review of private higher education colleges.

He joined QAA in October 2002 from Liverpool John Moores University, where he was Director for Partnerships and Widening Participation. Previously, Stephen held the post of Assistant Provost with responsibility for learning and teaching. He taught Human Geography for many years at the City of Liverpool College of Higher Education and at Liverpool Polytechnic. Before joining QAA, Stephen worked for both the Higher Education Quality Committee and QAA as an auditor and review coordinator.

Rebecca Maxwell-Stuart is the EHEA student expert for this workshop.
