

Project Title: Supporting Effective Dispute Resolution (SEDR)

Project Summary

SEDR is a five-year access to justice project implemented by the British Council, in partnership with The Asia Foundation (TAF), and funded by the European Union (EU) through a Contribution Agreement as part of its STRIDE Programme in Sri Lanka. The project will run from 2020 to 2025 and is valued at EUR 7 million. SEDR comprises four overarching results areas that seek to enhance the effectiveness and availability of dispute resolution mechanisms in Sri Lanka and to foster social cohesion and more inclusive community-state engagement.
